**WHEREAS** it has become necessary to reorganize the investment administration proclamation in a manner enable to strength and encourage the role and participation of diaspora and private investors in investing in production sector is a backbone for achievement of sustainable economic development that would bring radical change the live hood of the community in the Regional state.

**WHEREAS** it has become necessary to create an economic framework that fast-tracks the global competitiveness of the national economy, increases export performance, generates more and better employment opportunities, and facilitates sustainable and entwined linkage among various economic sectors;

**WHEREAS,** to these ends, it has Become necessary to revise the existing investment administration system in the Region to alleviate problems that investors where encountered so far and to facilitate the provision speedy and attractive service delivery to the investors. That may accelerate the enhancement of investment objectives the state keen to achieve.

**RECOGNIZING** that it has become essential to put in place a system of monitoring and supervision to ensure that investments deliver on promised potentials stated in national investment objectives and are operated in accordance with the law;

**NOW, THEREFORE,** in accordance with Article 49(3, A) of the Revised Constitution of the Somali Regional State, it is hereby proclaimed as follows:

**PART ONE**  
**GENERAL**

1. **Short Title**

This Proclamation may be cited as the **“Somali Regional State Investment Administration (as amended) Proclamation No 197/2020”**

2. **Definitions**

In this Proclamation, unless the context otherwise requires:

1. **“Investment”** means expenditure of capital in cash or in kind or in both by an investor to establish a new enterprise, or to acquire, in whole or in part, or to expand or upgrade an existing enterprise;
2. **“Enterprise”** means an undertaking established for profit-making;
3. **“Capital”** means local or foreign currency, negotiable instrument, machinery or equipment, building, working capital, property right, intellectual property right, or other tangible or intangible business assets;
4. **“Investor”** means a Domestic or Foreign investor who has invested capital in Regional state.
5. **“Domestic Investor”** means any one of the following who has invested capital in Ethiopia

- b) Muwaadin Itoobiyaan ah.
- t) Shirkadaha laga aasaasay Deegaanka ama dalka ee ay leeyihiin muwaadiniinta itoobiyaanka ah.
- j) Dawlada.
- x) Shirkadaha Horumarinta Deegaanka iyo kuwa Dalka.
- Kh) Iskaashatooyinka loo aasaasay hab waafaqsan shuruucda dhaqangalka
- d) Muwaadiniinta ama Shirkadaha wadamada shisheeye ee shuruucda dalku ogolaanayaan in loo aqoonsado maalgeliye wadani ah.
- r) Shirkadkasta oo si wada jir ah ay u aasaasaan dadka lagu xeeriyay xarafyada (b) ilaa (d) ee Qodob hoosaadka (5) ee Qodobkan.

- a) An Ethiopian National;
- b) An Enterprise incorporated in regional state and wholly owned by Ethiopian National.
- c) The Government;
- d) State or national Public Enterprise
- e) A cooperative society established as per the relevant law.
- f) A Foreign National or Foreign Enterprise treated as domestic investor as per the relevant law or international treaty ratified by Ethiopia;
- g) An Enterprise incorporated in Ethiopia jointly between any of the investors specified under Sub- article (5) paragraphs (a) to (f) of this Article;
- h) A Foreign National or Foreign Enterprise accorded a domestic investor investment permit as per laws which were in effect when the permit was issued but which have since been repealed and continues to operate in Ethiopia, provided that this applies only in respect of investments that are operational at the time of enactment of this Proclamation;
- 6. **“Foreign Investor”** means any one of the following who has invested foreign capital in Ethiopia:
  - a) A Foreign National;
  - b) An Enterprise in which a Foreign National has an ownership stake;
  - c) An Enterprise incorporated outside of Ethiopia by any investor;
  - d) An Enterprise established jointly by any of the investors specified under Sub-article (6) paragraphs (a), (b) or (c) of this Article; or
  - e) An Ethiopian permanently residing abroad and preferring treatment as a foreign investor
- 7. **“Public Enterprise”** means an enterprise wholly owned by the State government
- 8. **“Expansion”** or **“Upgrading”** means increasing in volume, by at least 50 percent of the attainable production or service rendering capacity of an existing enterprise, or increasing in variety at least 100 percent by introducing new production or service rendering line of an existing enterprise, or increment by both;

- 9. **“Gudbinta Tiknoolojiyada”** waxaa loola jeedaa gudbinta Cilmi aasaas u ah wax soo saarka, hirgelinta nidaam wax soo saar ama adeeg bixin oo casri ah, oo ay ku jiraan tiknoolojiga suuq-gaynta hase ahaatee, aan ku koobnayn iibka iyo dayn ku iibsiga alaabada.
- 10. **“Heshiiska iskaashiga dhoofinta ee aan la xidhiidhin raasamaalka shirkadaha ee lala galo shikado shisheeye”** waxaa loola jeedaa Heshiiska iskaashiga ee ujeedadiisu tahay 100% dhoofinta kaasi oo ay wada galaan maalgeliye wadani ah iyo shirkad shisheeye kaasi oo shirkada shisheeye fulinayso mid kamid ah ama dhamaan arrimaha hoos ku xusan:
  - b) Inay suurtoogeliso xidhiidhka suuqgaynta dibada uu sugan.
  - t) Nidaamka wax soo saarka alaabada la dhoofinayo.
  - j) Nidaamka Maamulka iyo maaraynta ganacsiga dibada.
  - x) Nidaamka suuqgaynta dibada.
  - Kh) istaraatiijiyada helitaanka Alaabada caydhiin ee loo isticmaalo waxsoosaarka alaabta la dhoofinayo
- 11. **“Dawladd”** waxaa loola jeedaa Dawlada Deegaanka Soomaalida.
- 12. **“Deegaan”** waxaa loola jeedaa Deegaanka Soomaalida.
- 13. **“Golaha”** waxaa Loola jeedaa golaha maalgelinta ee lagu aasaasay hab waafaqsan Qodobka 16<sup>aad</sup> ee Bayaankan.
- 14. **“Xafiis”** Waxaa loola jeedaa Xafiiska Maalgelinta iyo Qurbajoogta.
- 15. **“Qof”** waxaa loola jeeda qofka caadiga ah ama hay’ad kasta oo leh jiritaan sharciyeed.
- 16. Ereyada Bayaankan dhexdiisa loogu xeeriyay labku waxay sidoo kale dhaqangal ku yihiin dhedigga.

  - ሀ/ አስተማማኝ የውጭ ገበያ ግኝት፤
  - ለ/ ለውጭ ገበያ የሚቀርቡ ምርቶችን የማምረት ዘዴ፤
  - ሐ/ የውጭ ንግድ ሥራ አመራር ዕውቀት፤
  - መ/ በወጭ ገበያ የመሸጥ ስልት፤
  - ሠ/ ለወጪ ምርት የሚያስፈልጉ ጥሬ ዕቃዎች እና ግብዓቶች አቅርቦት ስልት፤
- 11. **«መንግሥት»** ማለት የሶማሌ ክልላዊ መንግሥት ነው፤
- 12. **«ክልል»** ማለት የሱማሌ ክልል ነው፤
- 13. **«ቦርድ»** ማለት በዚህ አዋጅ አንቀጽ 16 መሰረት የተቋቋመው የኢንቨስትመንት ቦርድ ነው፤
- 14. **«ቢሮ»** ማለት የኢንቨስትመንትና ዲያስፖራ ጉዳዮች ቢሮ ነው፤
- 15. **«ሰው»** ማለት የተፈጥሮ ሰው ወይም በህግ የሰውነት መብት የተሰጠው ድርጅት ነው፤
- 16. ማንኛውም በወንድ ፆታ የተገለጸው አነጋገር የሴትንም ይጨምራል፡፡

- 9. **“Transfer of Technology”** means the transfer of systematic knowledge for the manufacture of a product, the application or improvement of a process or for rendering service, including management and technical know-how as well as marketing technologies, but may not extend to transactions involving mere sale or lease of goods;
- 10. **“Export-Oriented Non-equity Based Foreign Enterprise Collaboration”** means a hundred percent export-oriented contractual agreement between a domestic investor and foreign enterprise in which the foreign enterprise provides, among others, all or some of the following:-
  - a) Guaranteed external market access;
  - b) Production know-how of products for export market;
  - c) Export business management know-how;
  - d) Export marketing know-how;
  - e) Strategies for the supply of raw materials and intermediate inputs needed for export products
- 11. **“Government”** means the Government of Somali Regional State;
- 12. **“Region”** means the Somali Regional.
- 13. **“Board”** means the Investment Board established under Article 16 of this Proclamation;
- 14. **“Bureau”** means the Investment and diaspora affairs Bureau.
- 15. **“Person”** means any natural or artificial persons.
- 16. Any expression in the masculine gender includes the feminine.

**3:- Xadka Fulineed ee Bayaankani**

Bayaankan wuxuu dhaqangal ku yahay dhamaan hawlaha maaklgelinta ee loogu awoodsiiyay Deegaanka Qodob hoosaadka (4) ee Qodobka 4<sup>aad</sup> ee bayaanka Maalgelinta federaalka ee tirsigiisu yahay 1180/2020.

**4:- Ujeedooyinka**

Iyadoo Ujeedoodada guud ee hawlaha maalgelinta ee deegaanku ay tahay in la hirgeliyo nidaam waxsoosaar tayadiisu sarayso, in kor loo qaado heerka nololeed ee bulshada islamarkaana abuura horumar dhaqaale oo waara ayaa ujeedooyinka gaar ahaaneed ee arrimaha maalgelintu waxay noqonayaan sidan hoos ku xusan:-

**3. Scope of Application**

This Proclamation shall apply to all investments that are under the Jurisdiction of regional state as per sub article 4 of article 4 of proclamation no 1180/2020.

**4. Investment Objectives**

The investment objective of the Regional State is to improve the living standard of the peoples of Ethiopia by realizing a rapid, inclusive and sustainable economic and social development. The particulars of the objective include the following:

1. to increase the Revenue earnings of the Regional state by encouraging the expansion in volume, variety and quality of the Regional state productivity and products;
2. To create more and better employment opportunity within Regional state and advance the transfer of knowledge, skills and technology required for the development of the regional state
3. To enhance the competitiveness of the national economy by promoting investments in productive and enabling sectors;
4. To augment the role of the private sector in the Regional State's economic development;
5. To exploit and develop natural, resources of the Regional state;
6. to create a conducive environment that attract and encourage domestic and foreign investors;
7. to encourage and ensure socially and environmentally responsible investments;

**AREAS OF INVESTMENT, FORMS OF ENTERPRISE AND CAPITAL REQUIREMENTS**

**5. Areas of Investment**

1. any investor may engage in any area of investment except where it is contrary to law, moral, public health or security.  
2. Areas of investment reserved for joint investment with the government, for domestic investors, and for joint investment with domestic investors shall be specified by a regulation to be Issued by the Executive Council of the Regional state.

**6. Investments Undertaken Jointly with the Government**

The Public Enterprises Holding and Administration Agency or an authority statutorily mandated to implement projects established by way of public-private-partnership, as appropriate, shall receive investment proposals submitted by any private investor intending to invest jointly with the government; it shall follow procedures established under the pertinent laws for decision, and, upon approval, designate a public enterprise or establish a project company to invest as partner in the joint investment.

**7. Forms of Enterprise for Carrying out Investments**

1. Investments may be carried out in one of the following enterprises:  
a) Sole proprietorship;  
b) Enterprise established at national or in the Region  
c) Regional state public enterprise  
d) Cooperative society formed in accordance with the relevant law.  
2. Any investment made in the forms prescribed under Sub-article (1) of this Article shall be registered in accordance with the relevant law.

**10. Cusboonaysin Fasaxa Malgelinta**

1. Fasaxa Maalgelinta waa in la cusboonaysiiyo sanadwalba ilaa waqtiga uu bilaabay shaqada ganacsiga ee soo saarista alaabada iyo adeegyada islamarkaana maalgeliyuhu uu helo shatiga ganacsiga.
2. Codsiga cusboonaysiinta fasaxa maalgelinta waa in maalgeliyuhu soo dhaweysto bil kahor maalinta uu ku egyahay fasaxii hore loo siiyay.

1. የኢንቨስትመንት ፈቃድ ባለሀብቱ ምርቱን ወይም አገልግሎቱን ለገበያ ማቅረብ እስከሚጀምርበት ጊዜ ድረስ በየአመቱ መታደስ አለበትና የንግድ ሥራ ፈቃድ መኖር አለበት።

**8. Minimum Capital Requirements for Investors**

1. Any investor, interested to invest in services sector, shall be required to allocate and deposit a minimum capital of birr **7,000,000.00** (Seven million).

2. Notwithstanding the provision of Sub-article (1) of this Article, the minimum capital required of an investor investing in agricultural production and livestock development shall be required to allocate and deposit a minimum capital of birr **3000,000.00** (Three million) .

3. The Investor specified under sub-article (1) and (2) of this article is required to deposit 25% of investment capital into an account opened in bank for this purpose and produce a copy of the certificate from the Bank.

**PART THREE**

**INVESTMENT PERMIT**

**9. Requirement of Investment Permit**

1. all investors who are investing in areas of investment reserved for Regional State shall pursuant with this proclamation be required to obtain investment permits:

2. No investor may, at any time, hold Regional State and federal investment permits simultaneously.

**10. Renewal of Investment Permit**

1. An investment permit shall ብ renewed annually until the investor commences marketing his products or services. as well as have business license.

2. An application for renewal of investment permit shall be submitted within one month before the end of a period of one year for which the permit was valid.

3. An investment permit shall be revoked if an investor fails to commence implementation of his project within two years of being issued the permit or has delayed the completion of the project by two years from the time that will be agreed with the Bureau.

4. Notwithstanding the provision of Sub-article (3) of this Article, the appropriate investment organ may renew the investment permit if it is convinced of the existence of sufficient cause prompting delay in the commencement or completion of the project.

**11 Transfer of Investment Project under Implementation**

Any investor wishing to transfer to another investor a project which is in implementation phase and for which no business license has been issued shall submit his request to the Bureau. The Bureau has the right to accept or deny the transfer of the project. Details shall be determined by a directive to be issued by the Bureau.

**12. Suspension and Revocation of Investment Permit**

- 1. he investment permit of an investor shall be suspended if the investor:
  - a) fails to submit accurate and timely information or project implementation report requested by the appropriate investment organ pursuant to this Proclamation, or intentionally or negligently presents incorrect report;
  - b) obtains the investment permit or secures its renewal fraudulently or by submitting a false information or statement;
  - c) uses the investment permit incompatibly with the objective for which it was issued
  - d) fails, without good cause, to renew the permit in accordance with the requirements specified in this Proclamation and regulations issued hereunder;
  - e) commences project implementation but fails to complete same within the time limit provided under Article 10 of this Proclamation;
  - f) Violates the provisions of this Proclamation, or regulations and directives issued to implement this Proclamation

4. An investor whose investment permit is revoked shall return all benefits received to the pertinent organs within one month of the revocation.

5. The measure of revocation of permit taken under this article may not waive the other criminal liability that the investor may be liable under applicable laws.

**13. Duties to Report**

Any investor who is issued an investment permit shall:

1. submit a biannual progress report on the implementation of his investment project to the appropriate investment organ;
2. provide information concerning his investment project to the Bureau.

- c) Examine and submit to the concerned organs investment applications forwarded to it.
- 12. Submit to the investment board and other concerned organs a report on the condition and status of investment works of the Regional state.
- 13. Carry out investment promotion agreements with third party for encouragement and expansion of investment supports and notify the executive council and investment board.
- 14. Shall handle land requests for investments by investors and submit to the Board and ensure its implementation upon approval.
- 15. compile any information related to investment land and other resources of investment potential and facilitate the provisions of basic infrastructure services ;
- 16. Decide on the duration of provisions exemption of land lease fees from the investor taking into consideration the advantage for public services of the project to be undertaken.
- 17. Serve as secretary of the Regional investment Board.

**28. Determination and Provision of Investment Land**

- 1. Where the bureau receives an application for, the allocation of land for investment, it shall by evaluating it within 30 days submit to the investment board for final decision.
- 2. The investment board shall give final decision on the land allocation request submitted to it within 15 days.

3. Where it is approved the allocation of land for investment the investment board decides in cooperation with the concerned administrative organs, shall cause the land to be transferred to the investor within one month.

**29. Duties of Concerned Organs**

1. organs responsible for the preparation of lands for investment, have the duty to regularly prepare lands for investment before the pre-developed lands finished off
2. As it is mandatory to observe and comply with the legal procedure laid down for the Valuation of compensation cost they shall be jointly and severally liable for any error that may occur during Valuation of compensation cost.
3. Concerned all organs shall have the duty to implement and enforce investment directives that are issued in accordance the law by the investment Bureau.
4. all investment services providers shall be provided with efficient provision of investment services
5. all concerned organs shall submit to the investments organs all the necessary information and date that may help for the enhancement and expansion of investment activities
6. Any concerned party shall co-operate in providing necessary support for the implementation of this Proclamation.

**30. Repealed and Inapplicable Laws**

1. The Somali Regional State investment administration Proclamation No. 96/2003 (as amended) is hereby repealed.
2. No law or customary practice shall have effect with respect to matters provided for in this law so far as it is inconsistent with this Proclamation.

- 1. The Council of executive organ shall issue regulations necessary for the implementation of this Proclamation.
- 2. The Bureau may issue directives for the implementation of regulations enacted pursuant to this Proclamation.

**33. Effective Date**

This Proclamation shall enter into force from the date approved by the State Council.
